- Read out the Bid Prices; the Bid Security provided; whether there is Power of Attorney provided; and the Bid Form signed to the hearing of all present;
- Allow Bidder Representatives to confirm Read-out Prices; and
- Record the Minutes of the Public Opening of Bids which will then be circulated to all Bidders who submitted Bids before the deadline for the submission of Bids.

#### **4.0 OPENING OF BIDS**

The Bids were opened and Prices read out and recorded. This is attached as **Annex 2**

**The following observations were made during the Opening of the individual Bids submitted:**

- (i) Messrs. Fairgreen advised that the Currency of their Bid was US Dollars and not Ghanaian Cedis as stated in their Bid Submission Form. The Price Schedule was stated to be in US Dollars.**
- (ii) Messrs. Sambus submitted only one document without any pricing, Bid Security, Power of Attorney or Bid Submission Form.**
- (iii) Messrs. Inlaks submitted a copy of their Bid and a Pen-drive late which were noted on the Bid Opening Sheet.**

#### **5.0 CLOSING**

The Procurement Agent Manager gave a firm assurance that MiDA and the Procurement Agent would ensure that the Evaluation Process was undertaken by an independent Evaluation Panel and the outcome communicated to all Bidders as soon as possible.
