- the Financial Offers of those Firms who attained the requisite 80 pass points to qualify at this stage for each Lot were opened, numbered and date-stamped,
- the Total Financial Offer Price for the Lot was read out to the hearing of all present and recorded,
- Copies of the Read-Out Prices as authenticated by the Representatives of Firms present were distributed to the Firm's Representatives, and
- the Minutes of the Public Opening of Financial Offers were recorded which were then to be circulated to the Firms at the earliest opportunity.

## **4.0 CLOSING**

The Administrative Controller, in his closing remarks, gave a firm assurance that the Evaluation Panel would commence work immediately, and wished the best Firm wins at the end of the process.
