#### **PART ONE: EXECUTIVE SUMMARY**

## A. Introduction

This Report covers Program performance for the period of January 1 to March 31, 2020, and captures Activities undertaken by the Millennium Development Authority (MiDA) toward the implementation of the Ghana Power Compact Program.

The Report also identifies challenges to the execution of the Compact and strategies put in place to ensure successful implementation of Activities.

In the period under review, significant progress was made in completing the procurement of Service Providers for the Compact Activities. The implementation of Contracts that have already been awarded also progressed steadily until travel restrictions imposed by countries and Corporate Entities in the wake of the COVID-19 pandemic, slowed down implementation of Project activities. Expected support from Implementing Entities was forthcoming.

## **B.** Highlights of January-March 2020 Achievements

During the reporting period, MiDA achieved the following major Milestones:

## ECG Financial and Operational Turnaround (EFOT) Project

Geographic Information System (GIS)

- Permission granted by the Ghana Civil Aviation Authority for flight to capture Aerial Imagery of the entire Accra East and West ECG Assets for the GIS Project.
- Variation Order approved to expand the Validation of ECG.

Pokuase Bulk Supply Point (BSP) and Interconnecting Circuits (ICC)

- Overall Project Progress is about 54%.
- The overall progress of the Pokuase BSP Interconnecting Circuits (ICC) is 36% complete.

#### Kasoa BSP

- Contract was signed with Siemens Energy SAS of France on January 16, 2020, and the Kick-off Meeting held on January 28-30, 2020.
- Key Project Management Plans submitted, i.e. Health, Safety, Environment and Social Management Plan (HSESMP), Stakeholder Engagement and Communication Management Plan, and Quality Management Plan were reviewed and approved.

## Primary Sub-Stations & Inter-Connecting Circuits (PSS + ICC)

• Contracts signed for the implementation of the Kanda and University of Ghana Teaching Hospital (UGTH) Primary Substations, and Interconnecting and Offloading Circuits Projects.

## Low Voltage (LV) Bifurcation

#### Achimota Work Order

- Project Documents including Environmental, Social, Health & Safety Management Plan (ESHSMP), Traffic Management Plan, Emergency Management Plan, Quality Management Plan and updated Work Plan were approved.
- MiDA, the Works Supervision Consultant (i.e. SMEC), and the Contractor completed Factory Acceptance Test (FAT) for LV DPs on March 6, 2020.
- A total of 2,800 Wood Poles (600 11-meter Poles and 2,200 9-meter Wood Poles) were planted, and 110 km AAC Conductors were strung during the Quarter.

#### Dansoman & Kaneshie Work Order

- Project Documents including Environmental, Social, Health & Safety Management Plan (ESHSMP), Traffic Management Plan, Emergency Management Plan, Quality Management Plan and updated Work Plan were approved.
- Construction Works commenced on February 5, 2020, with the planting of 2,000 of 9-meter Wood Poles and five (5) of 11-meter wood Poles.

## Mampong Work Order

- Project Documents including Environmental, Social, Health & Safety Management Plan (ESHSMP), Traffic Management Plan, Emergency Management Plan, Quality Management Plan and updated Work Plan have been approved.
- FAT for Distribution Pillars was carried out on January 27-31, 2020.
- Construction Works commenced on February 5, 2020. To date, 1,010 Wood Poles (made up of 421 9-meter Poles and 589 11-meter Poles) have been planted.

#### Access Project

• Final Draft Customer Census Plan was reviewed by Stakeholders and additional comments sent to the Customer Outreach, Facilitation Assistance for Connections, and Normalization of Services (COFANS) Consultant to incorporate in the Final Plan.

• The Regulatory Partnership Program (RPP) ensured PURC's participation in the January 2020 PURC/World Bank International Training Program on Utility Regulation and Strategy, and Leadership.

## Energy Efficiency and Demand Side Management (EEDSM) Project

- Completed Data Collection in Accra, Tema, Cape Coast, Sekondi-Takoradi Metropolis and Koforidua and Ho Municipals in a Nationwide Survey of Energy Consumption and Appliance Use Pattern in Ghana.
- Completed installation of Retrofits (Lighting Fixtures, Refrigerators, Air Conditioners and Ceiling Fans) and Real Time Energy Monitoring Systems in Buildings of six (6) Public Institutions – Korle Bu Teaching Hospital (KBTH), University of Ghana, Adabraka Polyclinic, Department of Urban Roads, Ministry of Health and Ministry of Education.
- Ghana's first Course Certifications Examination Results for the Sustainable Energy Audit Professional (SEAP), Sustainable Energy Management Professional (SEMP), and Energy Audit Practical (EAP) were submitted on January 20, 2020.
- Completed Monitoring Tools Design to capture, analyze and report Data at every level of the Monitoring Chain in Energy Efficiency and Conservation (EEC) Curriculum Updates in 30 selected Pre-Tertiary Schools across the three (3) zones in Ghana.
- Reviewed and approved five (5) Specifications presented by the Street Lights Replacement Works Contractors.

#### **Environment and Social Performance**

- Implemented the Resettlement Action Plan (RAP) and Community Engagement Plans for the Infrastructure activities under the EFOT Project.
- Engaged the Services of Design and Supervision Consultant for the construction of a Block of Flats at Kanda, which is a Resettlement activity for the Kanda Primary Substation.

#### Communications and Outreach

- Held Media Soiree to provide updates on the rescoped Compact Program Activities after the de-obligation of US\$190 million.
- Designed and published Bi-Weekly Media Advertisements to communicate benefits of Compact Program interventions.
- Coordinated Implementing Entity (IE) Stakeholder Committee Meeting.

## C. Challenges

The COVID-19 pandemic and the resulting travel restrictions and, in some cases, lockdown announced by Governments has caused delays to the completion of most Project Activities in the following ways.

- Suspension of Factory Acceptance Tests,
- Suspension of Field Activities involving the presence of foreign-based and Local Consultants and Fieldworkers.
- Suspension of Capacity Building Workshops.

#### PART TWO: PLANNED SECTOR ACTIVITIES AND DELIVERY

#### 2.1 INTRODUCTION

The Millennium Development Authority (MiDA) was established by an Act of Parliament (Act 702, 709 & 897 as amended). MiDA was established to oversee, manage and implement the Programmes under the Millennium Challenge Account for poverty reduction through economic growth as set out in each agreement between the Government of Ghana and the Millennium Challenge Corporation acting for and on behalf of the Government of the United States of America and for any other national development programme of similar nature funded by the Government of Ghana, a Development Partner or both and to provide for related matters.

The first 5-Year Millennium Challenge Compact was signed between the United States of America, acting through the Millennium Challenge Corporation (MCC) and the Government of Ghana (GoG in August 2006. The Compact implementation started on 16<sup>th</sup> February 2007 and ended on 15th February, 2012, and utilized approximately US\$547.009m grant funds

On 5<sup>th</sup> August 2014, the second Millennium Challenge Compact (also referred to as the Ghana Power Compact) between the Republic of Ghana and the United States of America was signed.

The Power Compact Program originally has a Budget of US\$ 498.2 million consisting of two Tranches of Program Funding amounting to US\$ 469.3 million and a Compact Implementation Funding (CIF) of US\$ 28.9 million. In addition, there is a Government of Ghana (GoG) contribution of not less than 7.5% (i.e. US\$ 37.4 million), bringing the total Compact Funds to US\$ 535.6 million.

The Tranche II Funds, which amounts to US\$ 190 million of the total, was contingent on meeting a number of Conditions Precedent (CPs), the principal one being Private Sector Participation (PSP) in ECG. MiDA worked with relevant GoG entities to meet the CPS. In particular, a private sector entity, Power Distribution Services Limited (PDS) was handed over the operations of ECG on March 1, 2029 under a 20-year Concession Agreement. However, GoG cancelled the Agreement because PDS did not fully comply with the requirements for the take-over. Thus, the US\$190 million Tranche II Funds are no longer available to be utilized under the Compact.

The Compact Program originally consisted of the following six (6) Projects:

- Distribution Projects
  - o ECG Financial and Operational Turnaround (EFOT) Project
  - NEDCo Financial and Operational Turnaround (NFOT) Project
  - Access Project

- Generation Projects
  - Regulatory Strengthening and Capacity Building (RSCB) Project
  - o Power Generation Sector Improvement (PGSI) Project
  - o Energy Efficiency and Demand Side Management (EEDSM) Project

The Compact Program seeks to address identified challenges in Ghana's Power Sector by providing an overall framework for strengthening the Ghana Electricity Distribution System. This was to be achieved by helping the Electricity Company of Ghana (ECG) and the Northern Electricity Distribution Company (NEDCo) to reduce their Technical and Commercial Losses and attract the needed Investment. The Compact was also to provide Technical Assistance in the areas of Corporate Governance, Technical Capacity of Sector Regulators, and the integration of Gender issues into the operations of relevant Sector Agencies.

The expected outcome for the Compact Program at the time of Inception was the modernization of the Power Distribution Companies and Capacity Building within the Power Generation Institutions in Ghana, and to present the Power Distribution Companies as credible Off-takers for prospective Independent Power Producers (IPPs).

Following the Mid-Term Review of the Program in February 2019, the NFOT and PGSI Projects were de-scoped. Some sections of the NEDCo Staff were opposed to the Management Contract component of the Project, thus stalling the work on the NFOT Project. In the case of the PGSI Project, most of the Activities planned under the Compact are being funded by the United States Agency for International Development (USAID).

#### 2.2.4 Environment and Social Performance

The Compact requires that all Projects are implemented in line with MCC's Environmental Guidelines, the International Finance Corporation Performance Standards on Environmental and Social Sustainability, and Ghana's Laws, Regulations, Licenses, and Permits. MiDA is therefore mandated to ensure such compliance.

The following were achieved during the period January-March 2020:

Implemented the Resettlement Action Plan (RAP) and Community Engagement Plans for the Infrastructure activities under the EFOT Project

- Worked with its resettlement and community engagement consultants to manage community engagement, outreaches and grievance management of the installation of the LV Bifurcation Projects in the Achimota, Dansoman and Kaneshie and Mampong districts. Activities carried out involved
  - i. Facilitated collaboration between the RAP consultants and the works contractors for smooth implementation of the works.
  - ii. Collaborated with the RAP consultants to carry out community town hall meetings including one at Larteh.

Monitored Contractors Health, Safety, Environment and Social Management Plans (HSESMPs) of the Infrastructure activities under the EFOT Project.

- Collaborated with its Health, Safety, Environment and Social (HSES) Consultant, SAL Consult to monitor the implementation of the HSESMPs of the Works Contracts. The objective of the monitoring and supervision of these Plans is to ensure compliance by the contractors and to avoid or minimize fatalities and accidents.
- Two quarterly HSES audits were conducted for the Pokuase BSP Project and the Achimota LV Bifurcation Project.

Engaged the Services of Design and Supervision Consultant for the construction of a 16-Unit 3-Bedroom Block of Flats at Kanda for families who will be affected by the construction of the PSS.

 MiDA has engaged the services of KNAK Design Partnership to carry out Design, assist in Procurement of the Works Contractor for the Project and supervise the construction of the Works. Designs have been finalized and preparation of tender documents have commenced.

Commenced processes to decommission Liquefied Petroleum Gas station at Kasoa

- MiDA has identified an LPG station adjacent to the site for the construction of the Kasoa BSP at Opeikuma, operations to pose risks of explosion to the construction and operation of the BSP.
- Engaged the management of the LPG station, Virgin Gas, to discuss Plans to relocate the business in order to safeguard the BSP which is a national asset.
- Engaged the RAP Consultant for the Kasoa BSP, SAL Consult to carry out the necessary valuation of the business to advise MiDA accordingly.

#### 2.2.5 Gender and Social Inclusion

Gender and Social Inclusion (GSI) in MiDA is aimed at ensuring a Gender responsive and socially inclusive Electricity service delivery and enhancing the Quality of Gender and Gender responsiveness in Compact activities. The GSI Activities in the reporting period covered the following.

Incorporation of Gender and Social Inclusive Considerations in Compact Implementation

 Provided support to Projects and Crosscutting Activities by reviewing Documents, participating in Kick-off Meetings and Workshops to ensure that Project teams and Contractors comply with Gender and Social Inclusion requirements.

Gender Audit/Gender Policy and Institutional Strengthening of ECG

- Facilitated the Strategic Planning Meeting for the ECG Gender Unit to position them as a leader in gender mainstreaming in the Energy Sector to ensure a gender-responsive and socially-inclusive Organization.
- Worked on the Draft Social and Gender Integration Plan (SGIP) Review and Update Process

#### **Institutional Strengthening Activities**

- Reports on the Proceedings of the Women in Energy Conference held during the previous Quarter, and the Strategy to Guide Female Employee Associations were finalized.
- Organized the Gender and Energy Working Group Meeting (GEWG) with participants sharing gender mainstreaming efforts in support of Compact activities and within their Organizations. MiDA GSI prepared and shared Gender

Audit Briefs with participants to aid them in the development of Terms of Reference for commissioning Gender Audit Consultants.

## Internship and Mentoring Program

- Compiled enrollment Data from new Educational Institutions and engaged with Energy Organizations for Internship slots.
- The Call for Applications for the 2020 Internship Program was circulated to Public Universities, Technical Universities, Technical Institutes, as well as NVTI Schools.
- Workshops for Mentoring Organizations to improve their effectiveness in supporting the Ghana Power Compact Internship and Mentoring Program (GPCIMP) Interns were held in Accra and Kumasi in January.
- The Directorate also commemorated the International Women's Day Celebrations on March 10, 2020, with panel discussions on progress and challenges faced by partner organizations in the Energy Sector. The theme for this year's celebration was #EachforEqual.

## Gender and Energy Working Group (GEWG)

 Organized the first meeting of the GEWG for the year. Key among the issues discussed were issues arising from the visit to the Implementing Entities on the integration of GSI in project activities, follow-up actions from the Women in Energy Conference as well as planning for 2020 International Women's Day.

## Collaboration Meeting with West Africa Energy Program (WAEP)

- Held discussions with representations of WAEP to explore areas where they can collaborate and build synergy with the MiDA GSI Programs, including activities after Compact Closure. The WAEP is part of the Power Africa Project with a duration spanning from 2019-2024.
- WAEP team expressed interest in collaborating with MiDA GSI on the Internship and Mentoring Program and the Institutionalizing Gender Activity

#### 2.3 MONITORING AND EVALUATION

The following M&E activities were carried out during the period January - March 2020.

## M&E Plan

 Commenced the Fourth Revision of the M&E Plan. This revision is largely focused on reviewing expected results due to the de-scoping of the Compact. The deobligation of the USD 190 million Tranche 2 Funds had resulted in the de-scoping of the Compact. The reduced Compact Funds was expected to negatively impact on some of the Indicator Targets in the M&E Plan.

Post-Compact M&E Plan

 Commenced discussions with MCC on the modalities for developing the Post-Compact M&E Plan. The National Development Planning Commission (NDPC) has been identified as the potential Lead Agency for the implementation of the Plan. Preliminary discussions were held with the M&E Directorate of NDPC to explore the Commission's willingness to lead this.

#### **Process Evaluation**

- Following the signing of a Contract with PricewaterhouseCoopers (PwC)-India, the Mid-Term Evaluation (MTE) of the Compact commenced with the Kick-Meeting on January 13, 2020. The main purpose of the MTE is to assess the extent to which the Compact is being implemented as planned. The MTE, together with the End Term Evaluation (ETE), which will be carried out towards the end of the Compact period, are expected to assess the progress made by the Projects under the Compact towards achieving intended outputs.
- The Draft Inception Report for the MTE Contract was received on February 11, 2020, and the Final Inception Report, which had the comments of MiDA incorporated, was received on February 25, 2020.

#### **Impact Evaluations**

## Impact Evaluation of Technical Loss Activity of EFOT Project

- Received from the University of California Berkeley (UCB) the Draft and Final Deployment and Testing Reports for the GridWatch Scale-Up Consultancy on February 3 and February 17, 2020 respectively.
- UCB presented a Report on the impact of COVID-19. The three largest impacts outlined relates to i) Supplier shortages, ii) Travel restrictions, and iii) Institutional restrictions on Research. This would cause them not meeting the April 13, 2020 timeline for Delivery 3(a) *Interim Report on Deployment to Targeted Districts within Accra*. The Contract end date remains the same notwithstanding. These timelines will be reviewed periodically.
- Following actions taken to handle the Supplier delay, more than half of the required parts had been supplied, with the remaining parts expected in May.
- GridWatch Devices initially installed in Achimota, Dansoman and Kaneshie ECG Districts continued to collect Data, while awaiting deployment of additional Devices, particularly in Dansoman and Kaneshie.

#### Impact Evaluation of the Overall Compact

• Signed the Household and Enterprise Surveys Contract and commenced implementation with a Kick-Off Meeting (held remotely via Zoom) on March 23, 2020. The Meeting brought together MiDA M&E, MCC M&E, NORC (the Consultant) and Mathematica Policy Research (MCC-contracted Independent Evaluator); as well as the Local Partners of NORC and Mathematica. The Draft Kick-Off Meeting Notes were received from the Consultant on March 26, for review by MiDA, MCC and the Independent Evaluator.

• Obtained the Integrated Business Establishment Survey (IBES 1) Data from the Ghana Statistical Service (GSS). The Data was to facilitate sampling by the Household & Enterprise Survey Consultant.

## Reporting of Results

- Received from the Data Quality Audit (DQA) Consultant the Inception Report for the Second Round of the Audit on January 30, 2020. The Data Collection Phase of the Audit was completed and the Data Collection Report was received on February 27, 2020.
- Submitted the Indicator Tracking Table (ITT) indicating Compact results for Quarter 14 (October-December 2019) and the Narrative Report for Quarter 15 (January-March, 2020) to MCC on March 10, 2020, as part of the Disbursement Request Package for Quarter 16 (April-June 2020).

#### 2.4 COMMUNICATIONS AND OUTREACH

This Communication and Outreach activities executed within the reporting period, is presented below.

## **Development of Communications and Outreach Strategy**

The Government of Ghana's termination of the Electricity Company of Ghana (ECG) Private Sector Participation (PSP) Concession Agreement with Power Distribution Services (PDS) Ltd affected MiDA and the Compact II Program's image. Most of the media coverage on the Compact II Program had been centered on the ECG PSP processes, with little publicity on the other Project activities.

For the above reason, though the Compact II Program had been ongoing for several years, MiDA's visibility and the publics' awareness of the Compact project activities were not adequate. There was the need for MiDA to step up information dissemination on its activities under the Compact Program and re-establish its image as a responsible and reliable Accountable Entity, hence the need for the development of the Compact II Communication Strategy.

The document received MiDA Board's approval and consequently became the reference document which mainly guided MiDA's communication and outreach activities. Its full implementation began on January 6, 2020. The following provides an update on the implementation of the planned activities in the Compact II Communication Strategy for the period January 6 to March 26, 2020.

The Communication Strategies, Activities and corresponding Results are presented in the Appendix.

## **Support to Projects**

Environment and Social Performance Unit: To aid in community engagement activities, the Communication Unit designed standard ID cards for the Resettlement Action Plan (RAP) & ESHA Consultants. The designs included the logos of the MiDA and the MCC to support the brand visibility efforts.

*Primary substation:* Supported Kick-off Meetings for the Primary Substation and Inter Connecting Circuits activities; and provided support in branding, developing and disseminating news releases to the media for publication.

Kasoa BSP Sod-Cutting: The Unit identified three service providers and sent out an event brief to them to submit their proposals for the management of the Kasoa BSP Sod-cutting event. The Unit was also represented at a Meeting with Siemens, Project Contractor to discuss preparations for the event. Preparations have been put on hold following the announcement of restrictions on public gatherings and other safety measures to curb the spread of the COVID-19 pandemic.

*MCC Team Visits:* There were two key visits from the MCC Team during the quarter. The first visit involved MCC Chief of Staff, Lara Smith and Emily Davis Vice President for Congressional and Public Affairs. The Communication Unit presented its strategy, supported with photography, to the team on their tour to some project sites in Accra.

*Board presentation*: At its meeting on March 10, 2020, the Unit updated the MiDA Board on progress and results from implementing the Communication Strategy they approved. The Unit also took feedback and suggestions on other activities to include in the Strategy.

## **Website Activity**

The MiDA website recorded a 4.4 percent growth in the reporting quarter. There have been 114,795 Visitors to the MiDA website since its launch in November 2015. This is an increase of 4,837 Visits from the 109,958 Visits recorded at the end of December 2019. Posts on MiDA's Facebook and twitter handles reached a total of 4,705 users on both platforms. These are organic records, i.e. earned media reach. There is an average reach of 1,568 each month.

#### Media Activity

Ninety-six media activities on MiDA and the Compact were recorded in the reporting period. The breakdown is as follows: Online, 42; Print, 11; Radio, 18; TV, 18; and Exclusive Interviews, 7.

#### **PART THREE: CHALLENGES**

#### 3.1 CRITICAL ISSUES

The support of Staff of the Implementing Entities is necessary for the success of the Compact.

The COVID-19 pandemic has resulted in delays to Contract Deliverables because of travel restrictions imposed by most Governments. Key Staff of Works Contract and Consultancy Firms are not able to travel. Factory Acceptance Tests (FAT) have been delayed or deferred in some cases, resulting in delays to the delivery of Materials and Equipment. FATs to be carried out by Third Parties have also been affected by Lockdowns.

#### 3.2 PROJECT-SPECIFIC CHALLENGES

## **3.2.1 Distribution Projects Challenges**

The challenges that have hindered the achievement of Targets in relation to the EFOT Project are as follows:

## **EFOT Project**

#### IT Infrastructure

- The GIS implementation has been delayed due to the extended length in time to secure a Permit for flight to capture Aerial Imagery of ECG Assets in Accra East and West Operational Regions. Permission had to be granted by Ghana Civil Aviation Authority, Lands Commission, National Security, and the Ghana Air Force. The permit was received in February 2020 after a seven-month process.
- As a result of the cancellation of the Data Center and Communication Network (DCCN), the implementation of the Meter Management System (MMS) that was depending on an upgraded Data Center had to be modified. The MMS will now have to depend on the ECG Data Center.

#### Pokuase BSP and ICC

- The lockdown by the Government of Ghana as a result of the COVID-19 Pandemic will affect Site work.
- FATs and shipment of Equipment expected from Manufacturers in Spain, Italy and India have been delayed by lockdowns in these countries.

### PSS + ICC

• Travel restrictions and Lockdowns as a result of the Covid-19 will cause delays to Works on the Primary Substations and Interconnecting Circuits.

#### Kasoa BSP

• The Kasoa BSP Activity, which already faces a very high Completion Risk, could be delayed further by suspension of Works due to COVID-19 related restrictions.

#### LV Bifurcation

- Achimota Work Order: Delayed delivery of the 3<sup>rd</sup> Lot of 120sq.mm AAC, 11kV Ring Main Units and LV DPs due to the COVID-19 pandemic.
- Dansoman & Kaneshie Work Order: Delayed manufacturing of the 11kV Ring Main Units expected from India due to the COVID-19 pandemic.
- Mampong Work Order: Delayed shipment of Pole-top Accessories, Cables, and additional Wood Poles due to COVID-19 pandemic.

#### Access Project

• In view of the de-obligation of the USD 190 million Tranche II Funds, the MCC funding for the Access Project is no more available. The Contract award is now contingent on receipt of GoG's payment of its contribution to the Compact. As of now, the earliest Contract signing date is in April 2020, with the worst-case scenario in June 2020. In either case, the Project could face completion risks since the Contract award has been delayed by at least 5 months.

## **3.2.2 Generation Projects Challenges**

The current issues with COVID-19 are impacting on all EEDSM and RSCB Projects, both Consultancy Services and Works Implementation Contracts. Consultants and Contractors are mostly working from home as directed by the government. Although Reports continue to be reviewed at home and conference calls are being held regularly, most of the current activities are field related and that has been put on hold because of the circumstances. Specific to the RSCB Project, there are third party impacts on the service providers to the RPP implementation.

Additionally, the unanticipated challenges particularly with regards to PURC's new request and involvement with the Regulatory Partnership Programme (RPP) during the Quarter has a potential knock-on effect on the original objectives of the RPP. MiDA Management intends to engage with PURC to determine the outcomes of their decision on the Commissioner-Level Study Tour.

There is a delay in the planning and implementation of an in-country Partnership Exchange Programme on Tariff Review Processes and Stakeholder Communication. This was due for completion in March 2020, but now postponed indefinitely. The delay was due to PURC requesting for a Commissioners Study Tour abroad, instead of the already planned programme as per National Association of Regulatory Utility Commissioners (NARUC) contract.

## **3.2.3 Cross-Cutting Projects**

#### Gender and Social Inclusion

Internship & Mentoring: Due to a temporary closure of all educational institutions within the country as a result of COVID 19, the Team could not embark on the Outreach to Educational Institutions with high female enrolment in STEM courses, as originally planned.

#### Communications and Outreach

Some activities scheduled for implementation in March have been put on hold as a result of the Government of Ghana's restrictions and safety guidelines to avert the spread of the COVID-19 pandemic. Activities such as the groundbreaking ceremony for the Kasoa Bulk Supply point and its related preparatory activities to be carried out by the Unit have been put on hold pending improvements in the current situation.

While many of the Communication Heads of the IEs have been responsive in attending meetings of the IE Communication Committee, their response towards developing a communication strategy to drive the Committee's joint communication activities have been rather slow.
